Report of the Clerk: (a) Iver Neighbourhood Policing Newsletter for January was circulated to councillors after the last council meeting; (b) SBDC, Nexus and NHS (Bucks & OxforDs Cluster) are organizing a Health and Wellbeing Day on Wednesday 29th February, 9.30am to 12.30pm at the Memorial Centre, Gerrards Cross; (c) Dr Matthews, Mr Wood and the Clerk had a meeting with Sgt Lucy Price – Community Messaging project has resulted in contacting 80 vulnerable people in the parish, an additional PCSO, Bill Pretty, is starting work in Iver, change in Neighbourhood shift patterns is not likely to happen until after the Olympics and the police did not know about the schools and village halls in Iver being included in the Olympic Evacuation Plan. Concern was raised again about speeding in Langley Park Road, High Street and Mansion Lane. It was agreed to look for data to provide evidence and then the possibility of setting up a Specific Issue NAG for Speeding. This will be discussed at the next meeting 2pm on 23rd February and members of the Highways & Partnership Committee are invited to attend; (d) Thorney Lake meeting on 1st February – update to be provided at the meeting.
